

INVITATION TO BID

SPIRIT TRAIL

Sealed bids for the Proposal for the Construction of the Spirit Trail STP 6300 (406) will be received at: Johnson County Courthouse, 300 North Holden, Warrensburg, MO 64093, until 1:30 o'clock P.M. (Prevailing Local Time) on the 30th day of March 2017, at the office of the Johnson County Courthouse, and at that time will be publicly opened and read. All bids shall be submitted as Sealed Bids.

The proposed work includes:

The construction of 22,430 linear feet of compacted aggregate trail 10' in width on the south side of Highway DD. The project begins on the eastern city limits of Warrensburg and ends at western boundary of the Knob Noster State Park and includes but is not limited to: grading, placement of compacted aggregate trail, concrete retaining walls, box culvert extensions, and any work considered incidental in accordance with the plans and specifications.

A pre-bid conference will be held at 1:00 P.M. on the 21st of March at the County Commission Office, 300 North Holden, Warrensburg, MO 64093. All bidders are encouraged to attend the pre-bid meeting.

A digital copy of the plans and specifications may be purchased at the office of the Great River Engineering (GRE), at 2826 S. Ingram Mill, Springfield, MO 65804 upon payment of \$75.00, which is not refundable. All bidders must purchase plans through Great River Engineering, Inc. and be on the planholder list in order to bid the project.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the United States Department of Labor (Federal Wage Rate), or by the Missouri Department of Labor and Industrial Relations (State Wage Rate), whichever is higher.

Johnson County hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2016 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works projects shall provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal. Johnson County reserves the right to reject any or all bids. The project will be awarded to the lowest, responsive, responsible bidder. The DBE Goal for this project is 11.00%. No 2nd tier subcontracting will be allowed on this project.
