

## **Downtown Streetscape Construction in the City of Smithville**

### **Notice to Contractors**

Sealed bids for City of Smithville Downtown Streetscape Phase 3, Federal Project number: TAP-3302(434), City Project Number: RFP # 23 – 12, will be received at: 107 W. Main Street, Smithville, Missouri 64089 addressed to Rick Welch until 2:00 o'clock P.M. (Prevailing Local Time) on the 18 day of June 2024, at the office of City Hall, and at that time will be publicly opened and read. All bids shall be submitted in the form of paper copy.

The proposed work includes: Construction of approximately 1,800 square yards of asphalt street replacement, 1,200 linear feet of concrete curb and gutter, 800 square yards of concrete sidewalk, 45 square yards of brick sidewalk, 500 linear of 15-inch through 18-inch storm sewer, 7 storm structures, 15 street lights with base, traffic signs, landscaping, and all associated appurtenances.

Contractors desiring the contract documents for use in preparing bids may also obtain a set of such documents from Drexel Technologies, 10840 West 86th Street, Lenexa, KS 66214. Bidding documents will be shipped only if the requesting party assumes responsibility for all related charges.

There is no pre-bid conference scheduled for this project.

All labor used in the construction of this public improvement shall be paid a wage no less than the prevailing hourly rate of wages of work of a similar character in this locality as established by the Department of Labor and Industrial Relations (Federal Wage Rate), or state wage rate, whichever is higher.

The City of Smithville hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.”

All bidders must be on MoDOT’s Qualified Contractor List per Section 102.2 from the current version of the Missouri Standard Specifications for Highway Construction, including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier’s check or a bid bond in the amount of 5% shall be submitted with each proposal.

The City of Smithville reserves the right to reject any or all bids.

The DBE Goal for this project is 10%.

No 2<sup>nd</sup> tier subcontracting will be allowed on this project.
