

**Invitation to Bid**  
**Old U.S. 40 – Veterans Memorial Parkway**  
**Warren County, Warrenton**

Notice is hereby given, that the City of Warrenton will receive sealed bids for construction of Old U.S. 40 Sidewalk Extension. The work will consist of installing new curbs and gutters, a 4ft wide sidewalk, and stormwater drainage improvements as specified in Project Plans and Project Specifications. All other incidental items of work will be shown and described in the Project Plans and Project Specifications.

Bidding documents will be shipped only if the requesting party assumes responsibility for all related charges. Corporate, certified, or cashier’s checks shall be made payable to Drexel Technologies, Inc. Cost of these plans are non-refundable.

Sealed Bids will be received by the City of Warrenton until 8:30 A.M. on Wednesday, December 20, 2023 and will thereafter be publicly opened and read aloud. All bids shall be submitted in the form of one original complete bid form accompanied with two copies. The project will be awarded to the lowest, responsive, responsible bidder.

The successful bidder shall be required to comply with the current State Statutory Provisions concerning the payment of Prevailing Wages on Public Works, Section 290.210 through 290.340 and 290.550 to 290.580 RSMo 2000, and shall pay to all workmen performing work under this contract not less than the prevailing hourly rate of wages determined by the Department of Labor and Industrial Relations of the State of Missouri.

Missouri Annual Wage Order 30 shall be in effect for this project.

Contractors and sub-contractors must adhere to the OSHA 10-Hour Training requirements.

Each bid must be accompanied by a cashier’s check, or certified check, or a Bid Bond executed by the Bidder and an approved surety company and payable to the City of Warrenton, in an amount not less than five percent (5%) of the sum total of the base bid.
