SEALED PROPOSALS for the Warren County Bridge Replacement Program, consisting of:

Construction of one (1) single span (50') steel I-girder bridge.

Structure No. 0570020 1 located approximately 3 miles South of Jonesburg, Missouri on Massas Creek Road in Section 25, Township 47N, Range 4W in Warren County, Missouri.

WILL be received until:

9:00 a.m. on Thursday, December 9th, 2021

at the office of County Commission, Warren County Courthouse, Warrenton, MO 63383 and at that time will be publicly opened and read.

Any and all bids received after the time specified above will be returned unopened.

The wage rates applicable to this project have been predetermined as required by law and are set forth in the bid proposal. When Federal wage rates are applicable and included, this contract is subject to the "Work Hours Act of 1962," (P.L.87-581; 76 Stat. 357) and implementing regulations. The higher of the Federal or State Wage rates shall apply.

Bidders are required to submit the corresponding documentation of enrollment in the E-Verify program. This documentation includes the Memorandum of Understanding between the company and Department of Homeland Security and the Affidavit of Compliance. MoDOT will accept the first page and the signature page of the agreement as proof of participation.

The County of Warren hereby notifies all bidders that it will affirmatively ensure that in any contract entered into pursuant to this advertisement, businesses owned and controlled by socially and economically disadvantaged individuals will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, creed, sex, age, ancestry, or national origin in consideration for an award.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

A certified or cashier's check or a bid bond in the amount of 5% shall be submitted with each proposal.

No 2nd tier subcontracting will be allowed on this project.

Proposals must be on forms provided and all unit price bids, extensions and totals provided thereon shall be completed fully.

The Warren County Commission reserves the right to reject any or all bids.

The project will be awarded to the lowest, responsible, responsive bidder.
