

NOTICE TO AIRPORT ENGINEERING CONSULTANTS

Projects may be subject to future receipt of Federal funding under the Federal Aviation Administration (FAA) Airport Improvement Program, as administered by the Missouri Department of Transportation (MoDOT) through the State Block Grant Program (SBGP). These projects may include the following:

1. 10-unit T Hangar expansion. Estimated cost \$800,000
2. Apron Expansion/Grading/Pond Removal. Estimated cost \$500,000.
3. New Entrance Road with parking improvements. Estimated cost \$750,000
4. Airport general pavement maintenance, i.e. crack-fill, seal-coat, overlay, grading, marking, etc. Estimated cost \$220,000.
