The proposed roadway will consist of 8 In. non-reinforced Portland Cement Concrete on 4 In. of compacted base material. This project also includes the installation of 4 In. thick exposed aggregate sidewalks, ADA compliant curb ramps, pavement markings for on street parking, and stormwater improvements.

All bidders must be on MoDOT's Qualified Contractor List per Section 102.2 of the Missouri Standard Specifications for Highway Construction, 2016 Edition including all revisions. The contractor questionnaire must be on file 7 days prior to bid opening.

Contractors and sub-contractors who sign a contract to work on public works project provide a 10-Hour OSHA construction safety program, or similar program approved by the Department of Labor and Industrial Relations, to be completed by their on-site employees within sixty (60) days of beginning work on the construction project.

Successful Bidder shall be required to comply in all respects with Federal and State Wage Rates, including applicable statutory provisions concerning payment of prevailing wages on public works projects, Sections 290.210 through 290.340 R.S. Mo. as currently amended, and shall pay to all workmen performing under work contract not less than prevailing hourly rate of wages as determined by the Department of Labor and Industrial Relations of the State of Missouri. The higher of State or Federal Wages Rates will apply to this project.

The City of Wentzville reserves the right to reject any or all bids.

The DBE Goal for Linn Avenue Revitalization Project is 9%.

No 2<sup>nd</sup> tier subcontracting will be allowed on this project.
