Attached is the sign in sheet showing who attended the meeting for the Route 61 Roundabout project in Jackson. This project is set to go out for bid on March 18, 2016. Listed below are statements or questions mentioned at the meeting.

1. J0S2279 is a Cost Share project with the City of Jackson, J0P3133 is pavement improvements north of the Roundabout.

2. Will be an additional JSP with dealing the Post Office property.

3. Asbestos testing will be done this week and report next week. If that happens, the quantities will be adjusted to exact quantities.

4. Timeline, Public Commitment and Traffic Control are critical as far as opening of Barton St. and the Roundabout. Liquid damages are set if this doesn't happen.

5. Traffic Management Plan is standard, Homecomers is mentioned as an additional date.

6. DBE program requirement is on this job. Contractor mentioned it seemed high. Jason will look into it.

7. Consent Decree in effect, pay close attention to runoff.

8. Post Office needs to be in the loop on all activities on their property. The contractor will relocate the mailboxes to new location.

9. Face of retaining walls is critical to match the look of the courthouse blocks. This will be approved by the engineer.

10. Eric discussed the plans in detail with and also mentioned the Utility Relocation plans by Strickland Engineering.

11. Contractor asked about utility relocates and if they would hold up construction, Eric said he would check into it and get an update.

12. Contractor asked about City concurrence on their utility relocates, Eric said they would also review what is done.
