Question 1: Clarification of page C-103:

REMOVE "2" HDPE forcemain"

REPLACE with: 2 ½ HDPE forcemain.

Question 2: Clarification of grinder pump specifications DWG-303:

REMOVE "103.5 feet of TDH"

REPLACE with: "46 feet of TDH"



Question 3: For the grinder station is 230, single phase on site?

Answer: Yes.

Question 4: Will taxes on material be required?

Answer: No, Tax Exempt Status: MHTC is exempt from paying Missouri Sales Tax,

Missouri Use Tax and Federal Excise Tax. However, the Contractor may

themselves be responsible for

the payment of taxes on materials they purchase to fulfill the contract. A Project

request if applicable.

Question 5: All work done on state r/w 10' off edge of road, correct?

Answer: Yes, with the exception to sheet C-101 see public water supply District #1.

Question 6: On the 2 1/2 F.M. can we use PVC or HDPE material?

Answer: Yes.

Question 7: Hold Points, can we backfill as we lay pipe or do we have to leave the trench

open all day?
