QUESTION 1)

Looking over the bid tabulation from 2011, I noticed that the estimated volume of grease was 3,103 lbs. I then looked at the estimated volume for the current bulk oil bid (2014) and I noticed that the estimated volume was 360 lbs. Is the lower quantity of 360 lbs. of grease accurate or should we look to base our pricing off a bigger amount of grease to be used?

ANSWER

Yes, this estimated quantity of 360 lbs. is accurate. MoDOT STL purchased 360 lbs. in the last year. This is only an estimate for the upcoming year. Quantities purchased may be fewer or greater than estimate.

MoDOT STL would like 120 lb. and 35 lb. containers for a-c above. Please keep in mind, these items must be bid per pound. The only exception is for item c, 75W90 there is an additional line in which vendors must provide pricing on 5 gallon containers (per gallon cost on bid).

QUESTION 3)

Which locations require bulk oil delivery and can we have a list of product volumes for each location that you have listed on Attachment A?

ANSWER

The location at 2309 Barrett Station has a Preventative Maintenance Truck that will need bulk 15W40 delivered to the truck. Otherwise, all other locations and purchases for 15W40, 10W30 and 5W20 will be 55 gallon drums. No, we are unable to provide a list of volumes for each location.
