Plan Sheet:

- Sheet 8 and 25: Install a 30"W x 18"T x 12"D cabinet matching specified cabinets for range hood. Add power from LPB circuit 14. Add vent to outside with wall cap as required.
- Sheet 9: Door number 8 and 9 must be changed to hardware group 1. Door number 14 and 15 must be changed to hardware group 2.
- Sheet 17: Install white steel closer trim in place of aluminum.
- Sheet 20: Install South air hose reels on ceiling centered in the building.
- Sheet 23: Plumbing Schedule Symbol AHR Air Hose Reel; Remove reference to wall mount 7'-0" A.F.F. Air Hose Reel will be ceiling mounted.
