The following questions were received and the responses are noted.

QUESTION 1: How many FEIN's will we be working with if we do business with the

MoDOT?

RESPONSE: One.

QUESTION 2: How many different groups would we be working with?

RESPONSE: Active, Retire, Long-term disability, Work-related disability, Survivors.

QUESTION 3: Do any of these groups consist of teachers? **RESPONSE:** Only if they are dependents under a subscriber.



QUESTION 4: Are these groups all on the same payroll schedule?

RESPONSE: Actives have two pay periods per month; all others have one pay

period per month.

QUESTION 5: How many are salary and how many hourly?

RESPONSE: 99 percent salary.

QUESTION 6: Are these groups all on the same payroll schedule?

RESPONSE: Same question as #4.

QUESTION 7: Do you break down MoDOT payroll records and HR records by

department?

RESPONSE: Yes.

QUESTION 8: Would the MoDOT be able to provide us one (1) payroll file and one (1)

HR file or would this information come from multiple systems?

RESPONSE: Would depend on the information requested.

QUESTION 9: What Safe Harbor method is the MoDOT currently using to track

affordability?

RESPONSE: We are not interested in a safe harbor to track affordability.

QUESTION 10: Does the MoDOT offer a minimum essential coverage plan, a minimum

value plan or both to its employees?

RESPONSE: Minimal essential coverage plan.

QUESTION 11: Are the MoDOT's benefits plans calendar year or non-calendar year?

RESPONSE: Calendar year.

QUESTION 12: Would you please describe the MoDOT's current benefits offering

process (electronic/paper)?

RESPONSE: Paper.

QUESTION 13: How does MoDOT track the day the offer was made currently, and who

is enrolled?

RESPONSE: All tracked through our employer portal.

QUESTION 14: Does the MoDOT have different waiting/tracking periods for benefits

offerings based on different groups?

RESPONSE: No.

QUESTION 15: When is the MoDOT's Open Enrollment (once a year, monthly, i.e.)?

RESPONSE: Every other year.

QUESTION 16: Does your insurance provider provide a report with everyone who

is/was covered under the plan (monthly/quarterly/yearly)?

RESPONSE: We pull this report from our own system.

QUESTION 17: Who administers (tracks changes) such as opt outs and dependents

coverage add on /opt outs?

RESPONSE: Employee Benefits staff.

QUESTION 18: Does the MoDOT currently use a monthly measurement or lookback

measurement period for tracking?

RESPONSE: Lookback.

QUESTION 19: Does the MoDOT currently offer Cobra? a. If yes, does the MoDOT

administer Cobra or does a third party?

RESPONSE: Yes. MoDOT.

QUESTION 20: How does MoDOT currently track all hours of service aside from

regular payroll hours (FMLA, Disability, Unpaid time off, Jury Duty

etc...)?

RESPONSE: All tracked through our employer portal.

QUESTION 21: Is MoDOT planning to automate the transferring of the files via SFTP?

If not would they be willing to use a different but equally secure method

for securely transferring the files?

RESPONSE: Prefer to use SFTP for file transfer.
