2.0 General Requirements:

- 2.0.1 This Invitation to Bid is to obtain pricing and roll off container for the accumulation of scrap aluminum material as generated by the St. Louis District signing/striping department and miscellaneous aluminum objects scrapped by the Department.
- 2.0.2 The contractor shall provide all deliverables/services to the sole satisfaction of MoDOT.
- 2.0.3 Unless otherwise specified herein, the contractor shall furnish all material, labor, facilities, equipment, and supplies necessary to provide the deliverables/services required herein.
- 2.0.4 The contract period will for six (6) months and will include two possible one-year options, to be exercised at the sole discretion of MoDOT.

A. Description

- 2.1 The contractor shall deliver an empty container to the Barrett Station Sign Shop at no charge to the District.
 - 2.1.1 Each empty container placed at the Barrett Station location must be accompanied by a weight ticket showing weight of empty container.
 - 2.1.2 Current requirements are 30-yard container, however requirements are subject to change.
 - 2.1.3 The Contractor will be required to pick up container within 48 hours upon notification and replace with an empty container.
- 2.2 Scrap Material primarily consists of discarded signs which may have printing on them. Also included will be damaged truck mounted attenuators or other miscellaneous aluminum product generally categorized as Old Aluminum Sheet and Cast.

B. Volume

2.3 Signing Department typically produces approximately 16,000 pounds (7 tons) of scrap sign material per month. This figure will increase during periods of high activity and does not include additional materials that may be added such as damaged TMA's or other.

C. Award/Payment

2.4 MoDOT shall make award to the highest and best bid. MoDOT reserves the right to reject any and all bids. Bids will be based on the published American Metals Market Consumer buying Price, St. Louis, MO. Bidders shall indicate their "margin" on the enclosed pricing page. Award of bid will be based on the highest net price per gross ton (or pounds); therefore, the bidder with the lowest margin per gross ton, will receive the award.
