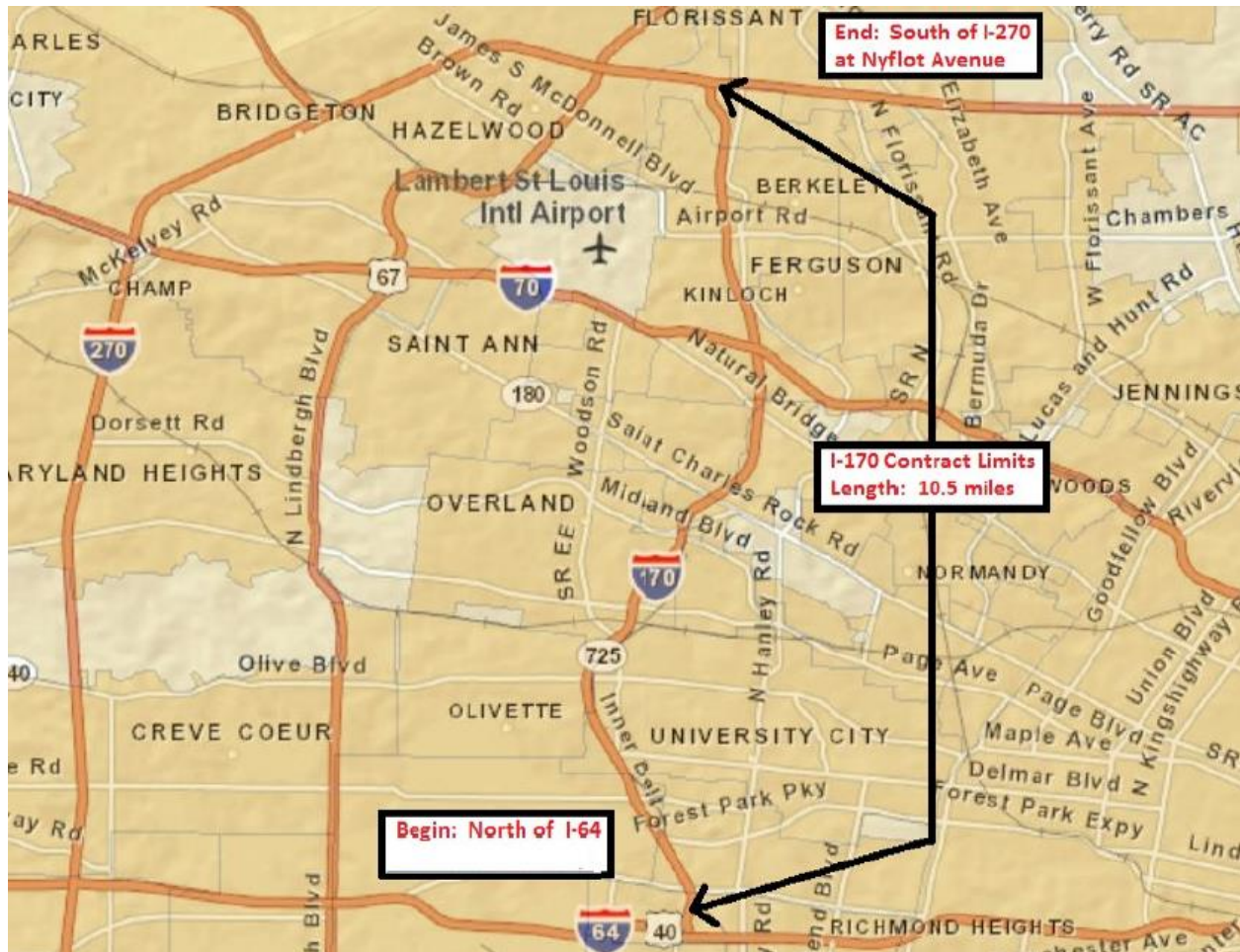


## Contract Limits and Location Sketch

### **Contract Term and Extension**

Initial Contract Term: Commencing [April 18, 2017](#) and shall terminate [November 30, 2017](#)  
First Extended Term: Commencing [April 1, 2018](#) and shall terminate [November 30, 2018](#)  
Second Extended Term: Commencing [April 1, 2019](#) and shall terminate [November 30, 2019](#)

### **Mowing and Litter Removal Cycles**

4 mowing and litter removal cycles are anticipated

### **Mowing Quantities**

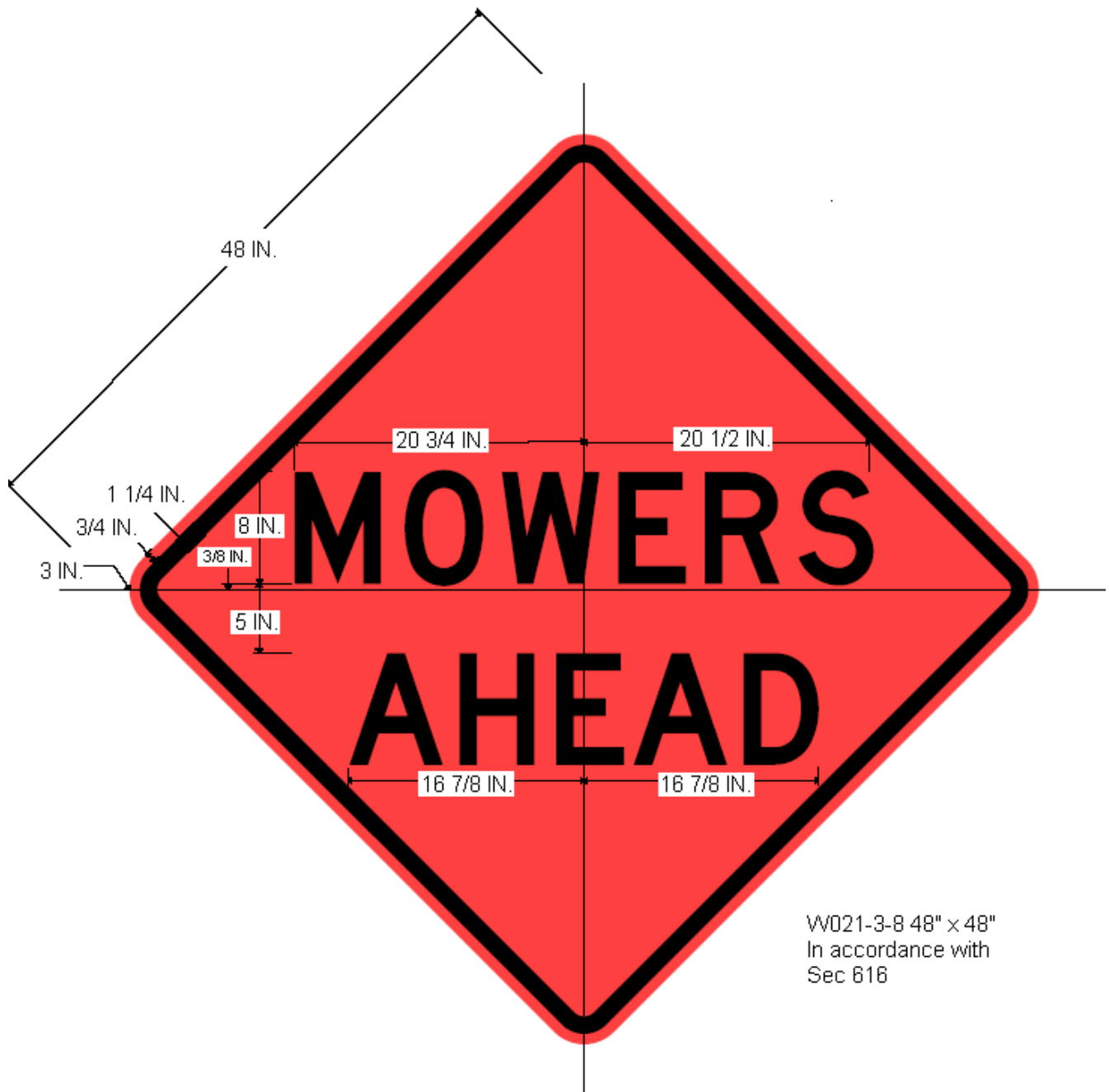

### **Mowing Height & Special Equipment**

- 1) Mowing equipment shall have a minimum adjustable height of **3 to 8** inches.
- 2) **No special equipment or equipment restrictions are required for this contract.**
- 3) All grass and vegetation shall be cut and trimmed to a height of **six (6)** inches unless otherwise directed by the engineer.
