
Dear Mr. Rahn:


The Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) have reviewed the Missouri Department of Transportation's (MoDOT) request to incorporate the Columbia Area Transportation Organization (CATSO) modification of their FY 2009-2012 Transportation Improvement Program (TIP), as further described in your letter of April 1, 2009, as an amendment to the FY 2009-2013 Missouri Statewide Transportation Improvement Program (STIP). The modification to be amended into the STIP involves the addition of two new MoDOT highway projects, one new City of Columbia transportation project and four new City of Columbia transit projects that will be financed with the American Recovery and Reinvestment Act of 2009 (Recovery Act) funding. A fifth City of Columbia Transit project is proposed for funding with Section 5309 funding.

The CATSO Coordinating Committee approved the TIP amendments on February 25, 2009. The Governor approved the CATSO amendments on March 31, 2009. Please note that the STIP amendment for the TIP modification to add the MoDOT projects 1S3009K and 1S3009N was previously approved by ONE DOT on April 2, 2009.

In accordance with 23 CFR 450.218(b), we have determined that this STIP amendment is based on a transportation planning process that substantially meets the requirements of 23 U.S.C 134 and 135, 49 U.S.C. 5303 and 5304 and 23 CFR 450 Subparts A, B, and C. Based on our review, this STIP amendment request is approved.
